# Why should you care about broadband?

Broadband, or high-speed internet, is vital for a community success and prosperity

- Telework and remote working
- Remote learning and online education
- Telemedicine and virtual doctor's appointments
- Economic development (business connectivity and participation in the global economy)
- Home values and expanding tax base
- Attract new residents and retain current residents
- Tourism
- Applying for jobs, filling out online forms, vehicle registration
- Allowing elderly residents to age in place and stay connected with family/friends
- Overall quality of life (Netflix, Hulu, YouTube, smart devices, etc)
- And much, much more!



#### Broadband Basics

#### **Technologies**

• Fiber, Coaxial Cable, Fixed Wireless, Copper/DSL, Satellite, Cellular Mobile

#### Speeds

- 25/3 Mbps as a baseline speed
- 100/20 Mbps as a more functional speed
- It is really more about the experience of the user

#### Regulation

- Broadband industry as a whole is largely de-regulated
- Absent additional funding like broadband grants, internet service providers often look at the business case and economics to determine when and where to expand services

#### By the Numbers...

- A broadband serviceable location (BSL) is "a business or residential location in the United States at which mass-market fixed broadband Internet access service is, or can be, installed."
- 154,953 total broadband serviceable locations (BSLs)
- 12,877 (8.31%) are considered unserved or underserved
  - 7,407 (4.78%) underserved (lacking 100/20 Mbps)
  - 5,470 (3.53%) unserved (lacking 25/3 Mbps)
- 561,504 Dane County Population in 2020
- 248,795 Dane County Housing Units in 2020
- 24,529 Affordable Connectivity Program (ACP) subscribers/households in Dane County, as September 2023

#### Past and Present Broadband Funding

- Wisconsin State Funding administered by Public Service Commission of Wisconsin (PSC)
  - 2014 \$500,000
  - 2015 \$500,000
  - 2016 \$1.5 Million
  - 2017 \$1.5 Million
  - 2018 Round 1 \$1.5 Million
  - 2018 Round 2 \$7.69 Million
  - 2019 \$7.05 Million
  - 2020 \$24 Million
  - 2021 \$28.4 Million
  - 2022 \$125 Million
  - 2023 \$16.6 Million



### Past and Present Broadband Funding

- Federal Funding administered by Public Service Commission of Wisconsin
  - 2023 Capital Projects Broadband Infrastructure \$42 Million (APPLICATIONS ARE CURRENTLY UNDER REVIEW)
  - 2022 American Rescue Plan Act (ARPA) \$100 Million
  - 2020 Coronavirus Aid, Relief, and Economic Security Act (CARES) ~\$5 Million
- Federal Funding administered by the Federal Communications Commission (FCC)
  - Rural Digital Opportunity Fund (RDOF)
    - Charter Spectrum and AMG Technology Investment Group, LLC (NextLink)
    - Primarily in Eastern Dane County
  - Enhanced Alternative Connect America Cost Model (E-ACAM)
    - TDS and Mount Horeb Telephone Company (MHTC)
    - Primarily in Western Dane County



#### Infrastructure Investment and Jobs Act

- The Infrastructure Law provides \$65 billion to connect all Americans to high-speed broadband internet that is affordable and reliable. Within the infrastructure law, there are several programs that support broadband planning, infrastructure, and adoption.
- Broadband, Equity, Access, and Deployment (BEAD) Program \$42.45 Billion
- Total Wisconsin BEAD Funding Allocation: \$1,055,823,573.71
- BEAD Program will be administered for Wisconsin by the Wisconsin Broadband Office at the Public Service Commission of Wisconsin (PSC)
- PSC will operate the allocation process: reviewing, scoring, and selecting recipients
- National Telecommunications and Information Administration (NTIA) will oversee to ensure compliance, approves proposals, and approve final allocation




# Broadband, Equity, Access, and Deployment (BEAD) Program

- Total Wisconsin BEAD Funding Allocation: \$1,055,823,573.71
- BEAD Purpose: Every Wisconsinite has access to reliable, affordable, high speed internet.
- Where will be targeted with BEAD funding?
  - Highest priority: *unserved* households and businesses lacking 25/3 Mbps.
  - Eligible: underserved households and businesses lacking 100/20 Mbps.
  - Also eligible: community anchor institutions lacking 1 Gbps, and other digital equity and adoption activities.

# Affordable Connectivity Program (ACP)

- The Federal Communications Commission's Affordable Connectivity Program (ACP) is a benefit program that helps ensure households can afford the internet connections they need for work, school, health care and more.
- Provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal lands.
- Enrollment in the ACP is open for households with at least one member qualifying under any of the following criteria:
  - Has an income that is at or below 200% of the federal poverty guidelines;
  - Participates in certain assistance programs, such as SNAP, Medicaid, Federal Public Housing Assistance, SSI, WIC, or Lifeline;
  - Participates in Tribal specific programs, such as Bureau of Indian Affairs General Assistance, Tribal TANF, or Food Distribution Program on Indian Reservations;
  - Is approved to receive benefits under the free and reduced-price school lunch program or the school breakfast program, including through the USDA Community Eligibility Provision;
  - Received a Federal Pell Grant during the current award year; or
  - Meets the eligibility criteria for a participating provider's existing low-income program.

#### Your Role as Municipalities

- Reach out if you're a broadband champion!
- Education: check out federal, state, regional, and local resources and maps
- Think about your areas of need...where are your underserved and unserved areas? Are the maps accurate?
- Communicate and work with internet service providers
- Prepare for BEAD \$1.055 billion is coming to WI for broadband infrastructure
  - Consider a potential financial commitment to a grant application
  - Gather letters of support and local data
  - Local endorsement for BEAD
- Focus on issues like affordability and promotion of ACP
- Maybe you want to start a local broadband workgroup/task force
- Consider Broadband Forward! and/or Telecommuter Forward! certification


